On September 07 the shareholders of KES DISTRI Frachtkontor GmbH have decided to dissolve the company. The company will be liquidated. Mr. Eduard Dubbers-Albrecht has been appointed as liquidator.

The main reason for the termination of KES DISTRI Frachtkontor GmbH is that it has not been possible to find a proper succession for Mr. Fuhrmann and Mr. Starkus in order to secure the future of the company.

Note: In clause 23 the ADSp 2017 deviate from the statutory liability limitations in section 431 German Commercial Code (HGB) by limiting the liability for multimodal transportation with the involvement of sea carriage and an unknown damage location to 2 SDR/kg and, for the rest, the customary liability limitation of 8.33 SDR/kg additionally to EUR 1.25 million per damage claim and EUR 2.5 million per damage event, but not less than 2 SDR/kg.
